Minutes

A meeting of the Board of Higher Education (BHE) was held at Framingham State University in Framingham, Massachusetts.

I. CALL TO ORDER

Chair Desmond called the meeting to order at 10:15 a.m. and invited Framingham State University President Timothy Flanagan to address the board.

II. WELCOME

President Flanagan welcomed the Board of Higher Education to the campus and provided updates on four topics: the professional certification which was awarded to the Framingham State police department by the Massachusetts Police Accrediting Commission; the work of two fashion design students which included participation in the Boston Symphony Orchestra's 3rd annual fashion contest, "Project Beethoven"; Athletic Director and Head Football Coach Tom Kelley's acceptance of the Gridiron Club of Greater Boston's Division 2-3 Coach of the Year

Award for 2011 at the Bob Whelan College Awards; the hiring of Eric P. Gustafson as the new executive director of development and alumni relations.

III. ACCEPTANCE OF MINUTES

Chair Desmond invited board members to introduce themselves. After the board members had done so, he then brought forth a motion to accept the minutes of the December 6, 2011, Board of Higher Education meeting. The motion was seconded and the minutes were approved unanimously by all board members present.

IV. CHAIRMAN'S REMARKS

Chair Desmond made remarks which included the announcement that Harvard Professor of Law David Barron is Governor Patrick's new appointment to the Board of Higher Education. He also noted the reappointment of Mr. Bernie Fulp to the Board. He commented as well on the TIMSS (Trends in International Mathematics and Science Study) Report which reflects the high achievements of K-12 work being done in Massachusetts. He noted that this distinction is motivating because these same students need to continue on to good post-secondary work. Chair Desmond then invited Commissioner Freeland to make remarks.

V. COMMISSIONER'S REMARKS

Dr. Richard M. Freeland, Commissioner of the Department of Higher Education, thanked President Flanagan for hosting the BHE meeting. He recognized Presidents Kennedy, Gomes, Glenn, and O'Donnell who were in attendance as well as Executive Officer William Hart and Gretchen Manning who are both from the Community Colleges Executive Office. He also recognized new State University Council of Presidents Executive Officer Vincent Pedone and colleague Jake Oliveira, also of the State University Council of Presidents. He also recognized University of Massachusetts Amherst Interim Dean of the School of Public Health and Health Sciences John Cunningham and Dr. Patricia Plummer, Senior Advisor to University of Massachusetts Senior Vice President for Academic Affairs, Student Affairs & International Relations.

Commissioner Freeland then thanked Governor Patrick for recognizing the role that community colleges play in the state's future. Regarding the budget, Commissioner Freeland thanked Governor Patrick for including funds for collective bargaining costs. He noted that the Governor proposed a significant increase in STEM funding, recommended a continuation of the Performance Incentive Fund, and an increase in the administrative line for the BHE/DHE. He also extended thanks to Secretary Reville.

Commissioner Freeland noted that a chief concern is the zeroing out of the Nursing and Allied Health Initiative line.

Commissioner Freeland then provided an overview of the day's agenda which included: committee reports; a vote on the appointment of John Cox to the presidency of Cape Cod Community College; Massachusetts Maritime Academy's 5-Year Plan; a vote on LEAP State Status Proposal; and three presentations from presidents who received first-round Performance Incentive Fund grants.

Commissioner Freeland then discussed remarks made by President Obama during a recent visit to the University of Michigan where he commented on the importance of maintaining affordability in higher education. Commissioner Freeland noted that the President is proposing

"Race to the Top" for education affordability and that, due to the work being done in higher education here in Massachusetts, we are in a good position to compete for those dollars.

Commissioner Freeland noted that Vision Project work continues in the college participation arena. Campuses have been asked to begin local discussions on a definition of college readiness that K-12 and higher education can agree upon. Regarding the college completion agenda, the Board of Higher Education has asked the campuses to review the final report of the Working Group on Graduation and Student Success Rates and set goals for graduation rates and student success. That information is being received.

He also noted that the Board of Higher Education will receive the final list of metrics for the first Vision Project Annual Report at the March board meeting.

Commissioner Freeland ended his remarks by commenting that it has been great to see Admiral Gurnon in the papers commenting on the Costa Concordia and representing the quality of Massachusetts public higher education.

VI. SECRETARY OF EDUCATION'S REMARKS

Chair Desmond invited Secretary Reville to make remarks. Secretary Reville noted that, due to a commitment with the Governor, he would need to leave the meeting at 11:00 a.m. He went on to reiterate Commissioner Freeland's remarks that in the Governor's budget a 5% increase was included for the community colleges, level funding was proposed for the Performance Incentive Fund, and a line was added for collective bargaining. He then stated that the Governor was pleased to make the appointment of David Barron as the newest member of the Board of Higher Education.

He then discussed Governor Patrick's decision to focus on the community colleges as the solution to Massachusetts' workforce situation. He stated that there is a mismatch between talent and opportunity-- between jobs available and candidates possessing the skills required to fill those openings. He emphasized that this set of proposals is designed to put community colleges in the center of a problem as a solution to the problem by increasing the capacities of the colleges to do this kind of work. Through budget and leadership policy changes, the system will become more integrated. Local boards with local mission statements that work within the Board of Higher Education system will continue to exist. The attempt is to strike a balance between state control and local control. Secretary Reville also stated that this set of proposals is not about only preparing people for jobs, as the Governor feels strongly about the importance of education and preparing people for educational opportunities. This is a set of proposals the Governor has been working on for some time and he is eager to hear from various parties on how to accomplish this. To that end the Secretary will be convening a small group of people, including business representatives and community college representatives to think about how to get this implemented.

Dr. Wayne Burton, President of North Shore Community College and Chair of the Executive Committee of Community College Presidents, began his remarks by noting that the community colleges serve more students than the state universities and the University of Massachusetts. He was honored to be invited to the Governor's State of the State address and emphasized that the community colleges take the challenge of workforce development seriously and are committed to helping the Governor achieve these goals. He also remarked that the Community College and that Interim President Ellen Kennedy is in place at Berkshire Community College. He added that President Glenn rounds out this good group, bringing incredible energy.

He then noted that the number of jobs available, as provided to him by the Executive Office of Education, may not be solely middle skill jobs. He then highlighted the data illustrating how well Massachusetts did during the downturn and noted that, while Governor Patrick is rightly concerned, the community colleges have played a tremendous role already.

President Burton also highlighted the 200 collaborations of the community colleges with employers and spoke of a letter he received from Governor Patrick congratulating him on North Shore Community College's partnership with General Electric. He also shared highlights from the Governor's visit to NSCC.

President Burton noted that 150 people met recently at Quinsigamond Community College to begin the work which will be funded by the Department of Labor grant which was recently awarded to the community college system. He also mentioned that North Shore Community College has been awarded a \$500,000 United States Department of Education grant through the Fund for the Improvement of Postsecondary Education (FIPSE) to help under-skilled adults find pathways to education and training for promising new careers. This builds on work done as part of several current initiatives, specifically the national "Breaking Through Initiative."

President Burton also mentioned that Secretary Bialecki's report, "Choosing to Compete in the 21st Century," is in legislature and he and Massachusetts Business Roundtable Chair Donna Cupelo have been asked to testify. He called the Board's attention to page 9 in the report, where three bulleted points refer to the good work of community colleges.

He directed the Board to the article authored by Donna Cupelo entitled, "Massachusetts is Choosing to Compete," and also to Northern Essex Community College (NECC) President Lane Glenn's article, published on EagleTribune.com, entitled, "Community Colleges Depend on Local Connections." President Burton pointed out that President Glenn noted that 95% of students who get degrees at NECC are employed. He urges that changes to a system that is working well should be considered carefully.

As a final note, President Burton also noted that it will be important to know what impact these proposed changes will have on schools' foundations. Will presidents be able to assure donors that their money will be used for the purpose the donor intends?

B. List of Documents Submitted by Dr. Meservey: "Council of Presidents Report to the Board of Higher Education, January 31, 2012."

Dr. Patricia Meservey, President of Salem State University and Chair of the State University Council of Presidents, began her remarks to the Board by reintroducing Vincent Pedone as the Executive Officer of the Council of State University Presidents and noted his strong legislative background and experience. She also thanked former Executive Officer Fred Clark for his leadership, first as Chair of the Board of Higher Education and then as Executive Officer of the State University Council of Presidents.

President Meservey noted that her comments are centered on looking for financial support for students. Affordability is of critical importance. She highlighted Pell Grant erosion and concerns about the tuition tax credit and increases on student loans.

President Meservey suggested doubling work study jobs not only because of the financial resource that they provide, but also because, with the students' jobs being on campus, , they can study more and commute less.

At the local level, President Meservey noted that the level funding from the Governor for state universities is appreciated, but she stressed that the universities will fall behind because their other expenses (e.g., energy expenses) will increase. She also expressed gratitude for the collective bargaining funds.

President Meservey also expressed concern about the potential for MASSGrant financial aid to be reduced. More and more students, she noted, are becoming eligible, and the amount per student is being reduced over time to a level not near enough to what is needed to help students afford their education.

On a positive note, President Meservey shared that the state universities have added more than 4,000 new graduates to the community, and she noted that 45% of job vacancies are for jobs that require baccalaureate degrees.

VIII. REPORT FROM STUDENT ADVISORY COUNCIL

Mr. Angel Donahue-Rodriguez, this year's student board member and a student at Salem State University, shared the following information with the Board: March 8th is Lobby Day. All segments of public higher education will be represented and messages will be coordinated to ensure that they are consistent. On January 6th, the Student Advisory Council sent letters to Governor Patrick, Speaker DeLeo, and Senate President Murray urging that more funds be allocated for higher education. Copies will be forwarded to board members. The Student Leadership Conference will take place at 8:00 a.m. on March 30th at Framingham State University. Student Advisory Council members are also writing op-eds about funding for public higher education in their school papers.

IX. MOTIONS

A. Board of Higher Education

1. Cape Cod Community College Presidential Appointment List of Documents Used: Presidential Selection Packet.

Chair Desmond invited Cape Cod Community College Board Chair Ralph Cahoon and Cape Cod Community College Presidential Candidate Dr. John Cox to the table. He then invited Chair Cahoon to describe the process of the presidential search. Chair Cahoon did so and described the qualifications and experiences of Dr. Cox that enabled him to stand out among the traditional and non-traditional candidates that were involved in the search. Chair Cahoon requested that the Board of Higher Education receive Dr. Cox's nomination and approve it.

Chair Desmond then invited Dr. Cox to address the Board. In his remarks, Dr. Cox addressed the current economic problem that Massachusetts is contending with and noted his own familiarity with the process of finding a common solution, as the Governor is trying to do. He commented that he is looking forward to the opportunity before him.

Chair Desmond brought forth the following motion. The motion was seconded and approved unanimously.

He urged the Board to vote the special mission renewal plan through.

Chair Desmond brought forth the following motion. The motion was seconded and approved unanimously.

Provided further that any material change to the Board approved MMA fiveyear Plan, including any change to the projection for total student charges, shall require approval by the Board pursuant to Section 7 of Chapter 15A of the General Laws.

Chair Desmond then asked Commissioner Freeland to introduce the set of Performance Incentive Fund (PIF) presentations. Commissioner Freeland provided a brief overview of the purpose of PIF and then invited President Mary Fifield of Bunker Hill Community College, President Timothy Flanagan of Framingham State University and Executive Vice Chancellor Jacqueline Moloney of the University of Massachusetts Lowell to the table to present.

A. Performance Incentive Fund Presentation (PIF) – Bunker Hill Community College

President Fifield discussed Bunker Hill Community College's use of the \$200,802 grant awarded through the Performance Incentive Fund. See printed presentation for details. After hearing President Fifield's presentation, student board member Angel Rodriguez commented with enthusiasm on the financial literacy program that is being created at Bunker Hill Community College. Discussion continued regarding the college's selection of LifeMap and inauguration of its Single Stop Center.

B. Performance Incentive Fund Presentation – Framingham State University

President Flanagan introduced Dr. Vandana Singh to discuss Framingham State University's use of the Performance Incentive Fund grant. Dr. Singh, described the University's use of the funds to redesign courses as STEM gateway courses. She described the challenges currently facing students in this area as: 1) being underprepared to take on this work or 2) lacking a positive attitude toward STEM work. As part of the solution, Dr. Singh went on to describe "Promising Syllabus" – a way to make the learning environment better. The "Promising Syllabus" is seen as an invitation promising the student, in an exciting and relevant way, what they will get out of the course. Dr. Singh detailed how she invites her students into the promising syllabi of her courses in environmental science and physics. The grant has given the professors a chance to share their successful methods with each other and it has changed their working environment from one of working in relative isolation to creating a massmovement in creating interest in STEM gateway courses.

C. Performance Incentive Fund Presentation – University of Massachusetts Lowell

Jacqueline Moloney, Ed.D., presented on behalf of Chancellor Meehan who was unable to attend due to a scheduling conflict. Dr. Moloney detailed the campus' use of the \$108,000 PIF grant and described how the campus' strategic priorities dovetail with three Vision Project key outcome areas: college completion, workforce alignment, and elimination of disparities. She introduced four programs for students transitioning to the university: science laboratory workshops, writing and calculus bridge summer workshops, innovative online supplemental instruction, and facilitated study groups. See printed presentation for details.

After Dr. Moloney's presentation, board members inquired about bringing certain programs to scale, receiving PIF updates on a regular basis, and disseminating the presentations to a broader audience of campus peers.
