## INTENT

Becker College, a non-profit, NEASC-accredited institution located in Worcester, Massachusetts, requests approval to offer the Bachelor of Arts in Early Childhood and Youth Education. The Bachelor of Arts in Early Childhood and Youth Education will provide professional preparation for students who want to work with young children in settings outside of public schools (i.e. child care centers, pre-schools, after-school programs). Students completing this degree will be prepared for the following roles: child advocates, childcare directors, program evaluators, coaches, teachers, mentors, and family support specialists.

Research on brain development, coupled with rising concerns about school readiness, has fueled an interest in the importance of the educational preparation of early childhood education teachers. The National Association for the Education of Young Children (NAEYC) recommends that all early childhood teachers have a bachelor's degree by 2015. Programs, such as Head Start, now require teachers to have a bachelor's degree or to be enrolled in a degree program. The Massachusetts Department of Early Childhood and Care Quality Rating Improvement System (QRIS) provides for a higher rate of funding to childcare providers who employ early childhood educators with associate and baccalaureate degrees in early childhood. Consequently, early education has become a growth industry. The College's proposed program intends to address these changes in the field.

The institution's Board of Trustees approved the program on June 8, 2012.

## INSTITUTIONAL OVERVIEW

Becker College is a small, private non-profit educational corporation, accredited by the New England Association of Schools and Colleges (NEASC). The College was incorporated originally by an act of the Massachusetts Legislature on December 4, 1940, as Becker School of Business Administration and Secretarial Science with the power to award the degree of Associate in Science, St. 1943, C. 555. In March 1977, the College acquired the Leicester campus and began offering courses in Leicester as well.

In 1990, an Act of the Legislature, amending the institution's charter, authorized a change of name to Becker College and award the Associate in Science degree in the following fields: liberal arts, business, secretarial science, education, health and animal sciences, technical studies, retailing and human services, environmental studies, law and criminal justice, communications, sports and recreation, travel, tourism and hospitality, and to offer any and all other courses or programs related or incidental thereto. In 1993 Becker filed Articles of Amendment pursuant to M.G.L.C. 69, s. 30 and came under the jurisdiction of the Board of Higher Education in May 1993 when it was authorized to award, in addition to its associate degree programs, the Bachelor of Science in Business Administration, Bachelor of Science in Legal Studies, and Bachelor of Arts in Psychology. In May 1996, the College was authorized to award the degree, Bachelor of Science in Veterinary Science. In April 1997, Becker College
was authorized to grant the degree, Bachelor of Science in Criminal Justice. In March 1998, the Board approved the Bachelor of Science in Kinesiology and two years later, in April 2000, the College was authorized to grant the Bachelor of Arts in Liberal Arts. In 2001, the Board of Higher Education approved the Bachelor of Arts in Design and in 2007, the Bachelor of Science in Nursing. The institution now requests the Bachelor of Arts in Early Childhood and Youth Education.

## ACADEMIC AND RELATED MATTERS

## Curriculum (Attachment A)

The proposed program's curriculum was developed building on the early childhood and elementary licensure programs already offered at the College and addresses the Massachusetts Department of Early Childhood and Care's Massachusetts Core Competencies for Early Education and Out-of-School Time Educators. The Core Competencies include an indepth examination of child development theory, skills that are essential to work directly with children and youth, and the leadership skills that are required to ensure program quality and accountability. The proposed program intends to provide graduates with the knowledge of the following areas:

- Growth and development of young children
- Guidance of and interaction with children and youth
- Partnerships with families and communities
- Health, safety, and nutrition
- Learning environments, curriculum and technology
- Observation, assessment, and documentation;
- Program planning and development;
- Professionalism and leadership, and
- The pluralistic society in which they will work.

The general education component includes courses in the humanities, social science, sciences, and mathematics. The program also includes practical experience and a capstone.

Students graduating from this degree will meet the Massachusetts Department of Early Education and Care (EEC) qualifications to be certified as a teacher, lead teacher, and/or director. Early education/childcare programs for children whose teachers have college degrees are deemed to be of higher quality by EEC and are reimbursed at a higher rate than those programs with lesser qualified teachers.

## Admission Requirements

First year students will be accepted if they have a 2.0 grade point average with a combined mathematics and reading SAT score of 800 . Transfer students will be accepted if they have a 2.0 grade point average from their previous college. Becker College accepts transfer credits from regionally accredited colleges with grades of $C$ or better.

## Tuition and Fees

Tuition for the program is $\$ 30,000$ per year. Annual fees are $\$ 1,500.00$. This information is for the 2013-14 academic year.

## Projected Enrollment

Student projections include internal demand and part-time students. The College anticipates a yearly rate of retention of $80 \%$.

## RESOURCES AND BUDGET

## Faculty and Staff

The degree will be part of the Department of Teacher Education and Family Studies. The department includes the Bachelor of Arts in Psychology, the Bachelor of Arts in Psychology with a concentration in Early Childhood Education, and the Bachelor of Arts in Liberal Arts with a concentration in Elementary Education. Students will take core courses with students in Teacher Education.

The faculty who will be teaching in the proposed new program include existing faculty. These include three full-time faculty, two of which are terminally qualified, in addition to currently retained long-term adjuncts. The institution anticipates needing to hire additional full-time faculty as the program grows.

## Library Resources

Becker College provides library services for both campus locations; Ruska Library in Worcester and Swan Library in Leicester. Both libraries hold 61,000 print volumes altogether. In addition, the libraries subscribe to 150 online/print journals and provide access to 1,000 full-text journals through database subscriptions, all of which cover educational topics, in support of the Bachelor of Arts in Early Childhood and Youth Education.

Becker College participates in the Academic and Research Collaborative (ARC), a group of central Massachusetts academic, public, and institutional libraries, which allows reciprocal borrowing for the College community and professional development for library staff. For education and related subjects, the Becker libraries currently hold 2,400 books, which is about $4 \%$ of the total book collection.

## Budget (Attachment B)

A multi-year budget projection has been developed for the proposed program.

## EVALUATION

## External Review

The proposed program was evaluated by an external visiting committee comprising of Maureen J. Provost, Associate Professor, Mount Wachusett Community College; Louise Boyle Swiniarski, Professor, Director of the Northeast Global Education Center; Salem State University; Lisa Van Thiel , Senior Early Childhood Specialist, Institute for Community Inclusion, Adjunct Faculty, University of Massachusetts Boston and Eleonora Villegas-Reimers, Associate Professor, Wheelock College.

The Visiting Committee reviewed the petition and appendices in preparation for the site visit, which took place on July 25-27, 2013. During the visit, the Committee met with administrators, faculty, staff, and students; and toured the facilities. The criteria that guided the review were the standards currently utilized by the New England Association of Schools and Colleges, supplemented by the criteria of the Independent Institutions of Higher Education Standards, 610 C.M.R. 2.08 (3) (b) through (g).

The Visiting Committee expressed support for the proposed program and made recommendations for improvements mostly in the following standards: planning and evaluation; the academic program and library resources.

- While the program's current faculty's qualifications meets minimal standards, the visiting committee was concerned about the impact of growth on faculty resources, the Visiting Committee recommended that the College develop a hiring plan that establishes a strategic approach to recruiting and hiring future full-time faculty prior to the fourth year of the program as originally planned.
- Revise and resubmit syllabi to express the academic rigor of the course, including a more through description of assignments, forms of evaluation, and connection to ECC's Core Competencies.
- Reflect the inclusion of the "youth" in the degree title in the syllabi or revise the title of the degree to solely include early childhood education
- Provide sufficient and consistent financial support to the library to develop and enhance resources for the proposed program

In response to the specific recommendations outlined above, the institution provided evidence documenting changes in the hiring plan to anticipate hiring a full-time faculty person as early as September 2016 and the budget reflects this change. The program's courses were revised and strengthened per the visiting committee's recommendation. Course content and readings now clearly cover content from birth to age eight; hence, the inclusion of the word "youth" in the degree title is appropriate. The institution also provided evidence of sufficient support to
develop and enhance library resources. After reviewing the institution's response to all of its recommendations, the visiting committee felt that the institution had responded adequately.

## PUBLIC HEARING

The required public hearing was held on November 26, 2013 at the Department of Higher Education. No comments were offered in opposition to the proposed program.

## STAFF ANALYSIS AND RECOMMENDATION

After an evaluation of all documentation submitted, staff is satisfied that the proposed Bachelor of Arts in Early Childhood and Youth Education meets the criteria set forth in 610 CMR 2.08 (3) in the Degree-Granting Regulations for Independent Institutions of Higher Education accredited by the New England Association of Schools and Colleges. Recommendation is for approval.
