FISCAL YEAR 2011 NEED-BASED TUITION WAIVER AWARDS

MOVED: The Board of Higher Education requires that each institution provide a

program of need-based tuition waivers to qualifying students and authorizes the Commissioner to administer the Need-Based Tuition Waiver Program at the level of \$18,095,495 for Fiscal Year 2011 with institutional need-based tuition waiver awards not to exceed the

allocation, as attached.

Background

Each year the Board of Higher Education approves the total of Need-Based Tuition Waivers to be expended at the public higher education campuses. Tuition Waivers do not represent any net revenue change to the institutions, as tuition is typically collected and remitted to the Commonwealth's General Fund.

Decisions on how Need-Based Tuition Waivers are allocated to institutions are based on student financial need, which is defined as allowances or Cost of Attendance (tuition and fees, books, room and board, transportation, etc.) minus the Expected Family Contribution.

The authorized level of expenditure for the Need-Based Tuition Waiver is based on aggregate student financial need, which is determined by:

- a) the amount of aggregate financial need of public higher education students,
- b) the amount of current financial aid grant support provided to public higher education students, and
- c) the total unmet financial need of public higher education students.

This motion recommends holding level authorized tuition waiver funding for FY2011. The Board of Higher Education will conduct a mid-year review of expenditures in the Need-Based Tuition Waiver program and, based upon the results, may redistribute unused tuition waiver dollars.
