Dear Commissioner Freeland,

Please be advised that this morning, at the Middlesex Community College Board of Trustees meeting, as chairman of the board, I brought forth a motion to recognize and laud the achievements of our outgoing president, Carole Cowan, who has served as a member of this college since 1976, and as its third president since 1990. As chairman, I made a motion to name our main city of Lowell campus building in honor of Dr. Carole A. Cowan, a motion that passed with the unanimous support of the board. This honor, I add, directly conforms to the Board of Higher Education's naming guidelines as well as the college's own internal policies and guidelines in terms of naming opportunities for any of its properties.

I come to you as Commissioner of the BHE to ask for your approval on this honor, as I know the Board has helped craft specific guidelines regarding the naming of state properties in recent years.
