Background

The Alternative Tuition Program allows residents of New York to attend Massachusetts College of Liberal Arts and Berkshire Community College at tuition rates set at reduced out-of-state rates. The rate currently is set at 150 percent of resident student tuition and mirrors the rate charged to students under the New England Regional Student Program through the New England Board of Higher Education (NEBHE). New York is not a NEBHE participant.

The number of students accepted each year under the alternative tuition arrangement is restricted.

The Alternative Tuition Program supports efforts at both institutions to increase enrollment. The program also provides an important link between the Berkshires and the Albany region for the Commonwealth and the county to develop strategies to strengthen and expand the regional economy.

At Berkshire Community College, 39 New York residents are currently enrolled under the Alternative Tuition Program. The College seeks to maintain its enrollment cap at 100 students for FY2019. At MCLA, 253 New York residents are currently enrolled under the Alternative Tuition Program. MCLA has an enrollment cap of 306 students and seeks to maintain that for FY2019.

Dear Deputy Commissioner Simard:

MCLA appreciates the continued support from the Department of Higher Education for the alternative tuition program for New York state residents. We wanted to provide you with this information in advance of the next BHE fiscal affairs meeting schedule for January 16, 2018.

DHE has consistently authorized MCLA to enroll up to 306 'new' students from New York State at a rate (\$1,545 per academic year) which mirrors that charged to students under the New England Regional Student Program through the New England Board of Higher Education.

Currently 253 students receive the benefits of the alternative tuition program. We also wish to continue the program at the same rate.

By capitalizing on our proximity to New York State, this important program has supported increased enrollment while not displacing any Massachusetts students. We are pleased with the results to date and look forward to continuing with this alternative tuition program for New York students, and maintaining the 306, 'new' student limit, already in place.

As you know, Berkshire Community College serves a diverse population of traditional and non-traditional students from Berkshire County. Given our westernmost location, we also attract students from contiguous states, including Connecticut, Vermont, and New York.
