I. CALL TO ORDER

Committee Chair Hopcroft called the meeting to order at 1:06 p.m.

II. ACCEPTANCE OF MINUTES

Mr. Adelman provided the committee with an update on the proposed FY20 rent schedule for the State Universities. He explained that rents fund the costs of operating the campus residences, as well as the debt service, insurance premiums, deposits to capital improvement reserves, and MSCBA operating costs. The recommended schedule of residence hall rents averages \$8,273 in FY20, an increase of 3.3% over FY19 due primarily to higher costs for debt service.
