# I. CALL TO ORDER

Board Chair Chris Gabrieli ("Chair Gabrieli") then called the meeting to order at 10:07 a.m. Department of Higher Education (DHE or Department) Chief of Staff Elena Quiroz-Livanis took roll call attendance (see above for attendance roster).

# **II. PUBLIC PARTICIPATION**

Chair Gabrieli reported that the Board did not receive requests for public comment.

## III. WELCOME

Chair Gabrieli welcomed the Board to the fourth BHE meeting of the academic year. He briefly went over the agenda items to be discussed.

# V. REMARKS & REPORTS

# **A.** Chair's Remarks

Chair Gabrieli noted that a retreat is being scheduled for the summer and that the Board members will be receiving scheduling inquiries from Department staff about the retreat, to help identify a date. In addition to the retreat being a great opportunity for Board members to meet in person, Chair Gabrilie said the retreat will offer the opportunity to seek input from Board members on board operations and

activities that are going well and not as well, including how the Board is operating with the recent shift to utilizing advisory committees as a key governance mechanism.

Chair Gabrieli was pleased to report on the Governor's proposed budget, which hallmarks a greater investment in higher education. Chair Gabrieli praised the 20% proposed budget increase for Massachusetts higher education and thanked the Governor for her attention. Chair Gabrieli highlighted other main elements of the proposal, such as financial aid to help lower-income students with accessibility to higher education without taking on too much debt.

### **B.** Commissioner's Remarks

Commissioner Ortega announced a new addition to his team, stating that he was pleased to introduce and welcome Dr. José Luis Santos to the role of Senior Deputy Commissioner and Special Advisor to the Commissioner. Dr. Santos is an accomplished higher education equity-centered professional with extensive experience in education technology and public policy. Research capacity enhancement, coalition building, and advocacy will be some of his areas of focus. Senior Deputy Commissioner Santos thanked Commissioner Ortega for the introduction and stated that he looked forward to working with the Board.

Commissioner Ortega discussed the New England Commission on Higher Education's (NECHE) recent decision to withdraw the accreditation of Bay State College, a proprietary institution operating in Massachusetts and authorized by the BHE to grant degrees. The effective date of NECHE's decision is August 31, 2023, though the institution is appealing the decision. Unless otherwise rescinded or amended on appeal, the NECHE decision means that Bay State College will no longer be authorized to enroll students as an accredited institution as of August 31, 2023. The Department continues to work closely with the college to advance contingency closure planning and serve the best interests of the students and faculty. The Department will ensure that students have multiple transition options in the event of a closure. Commissioner Ortega noted that he will keep the Board informed on the Bay State College matter as it continues to evolve.

Commissioner Ortega reported on the Governor's budget proposal, noting that higher education was prominent. The Governor's 2024 budget recommendation will help the Department make the system of public higher education more competitive, affordable, and equitable. Investing in students and families to make college more affordable is a highlight of the budget. Another highlight is providing the institutions with resources to support students. Commissioner Ortega asserted that the proposed investment in higher education would be important for the public system of higher education as it would help serve the needs of current and future students.

Commissioner Ortega discussed a key element of the budget's proposed investment in higher education - financial aid. One category of this element is a proposed investment of \$20 million in the MassReconnect Program, which will allow students aged 25 and older to return to school and return to the pathway to achieving a post-secondary education. This opportunity will greatly serve

students who had to discontinue school because of life circumstances. Commissioner Ortega noted that he is meeting with the financial aid officers in April 2023 to discuss how to maximize the potential of financial aid to serve the needs of students.

Commissioner Ortega closed his remarks by sharing his appreciation for the support during the start of his tenure.

**C.** Secretary of the Executive Office of Education's (EOE) Remarks

Assistant Secretary Bob LePage attended the meeting as Secretary Patrick Tutwiler's designee and thanked Department staff for their partnership in the budgetary process, along with the Department's overall work on several fronts.

# Community College Segmental Report

MassBay Community College President Podell President Podell opened his remarks by noting that the Community Colleges are thrilled by the Governor's historic budget proposal. He expressed support for the proposed H1 funding of \$18 million for the Community College Success Fund, which helps students facing barriers, including economic disadvantages and disabilities. President Podell added that he is pleased that the budget proposal will mitigate the need for Community Colleges to increase their fees for 2024.

President Podell noted that the Community Colleges are seeking to add a separate \$15 million line item to continue the work of the education and training fund (ETF), which is currently supporting high-demand workforce training programs at the Community Colleges. It is estimated that the current round of ETF funding will train 1,500 students, and President Podell hopes to see another round of funding to train many more.

President Podell noted that he is looking forward to working with the Secretary and the Department on guidelines for a broader program serving all residents in the Commonwealth and its state-wide implementation. He supports dual enrollment and early college funding.

Salem State University President John Keenan noted that the Frederick E. Berry Institute of Politics was thrilled to host its very first alternative spring break at the Massachusetts State House. Fifteen (15) students were selected through a competitive application process to participate in a three-day overnight conference at which they engaged with elected officials, policymakers, lobbyists, and activists to better understand the Massachusetts legislative process and to learn how the Commonwealth is tackling some of its most pressing social issues.

President Keenan expressed agreement with Chair Gabrieli that the Governor's FY2024 proposed budget represents a historic high point. President Keenan noted that the budget recommendations would expand the MassGrant Plus Program to provide need-based financial assistance to public higher education students by funding comprehensive student success supports, campus-based Equity Diversity and Inclusion initiatives, and student behavioral and mental health programs. He added that the budget's recommended investments in public higher education would begin to address affordability while ensuring the continuation of high-quality and meaningful post-secondary degree pathways. The Governor's spending plan also includes funding to implement a price lock guarantee on tuition and fees, which President Keenan supports, not only for incoming students but for all current students. However, for the price lock guarantee to work without burdening university finances, funding will be needed for the costs associated with their labor contracts, unfunded campus fringe benefit liabilities, and passage of H1 funding levels for the State Universities.

Chair Gabrieli opened the floor for questions to the presidents. Board Member Judy Pagliuca asked what types of programs are gaining market share within the system, and which are losing market share? President Podell answered that among their academic programs, the community colleges have capacity in many of them. Health Sciences are a hard area to grow because it requires clinical placements, and the faculty-student ratios are controlled by accreditation agencies. The segment is working hard to grow them even though it is very, very difficult. We have more capacity in IT and cybersecurity, and in areas like criminal justice and automotive technology. The Education Training Fund program is for short-term and non-credit programs where we have a very great capacity for growth.

President Keenan added that there is a crisis in the nursing sector and the State Universities have been working with the Department and others to address this. He noted his optimism to address critical workforce shortages as a result of the proposed investment in public higher education, citing affordability as a challenge students face. President Keenan said that those resources would make a major difference and he hopes to see public higher education in the Commonwealth affordable for anybody that wants to attend.

# **E.** Report from Student Advisory Council (SAC)

Student BHE Member Travis Lawrence noted that he is excited to work with Secretary Tutwiler, who previously shared his personal story of how and why education is important to him, as well as his plans on how he will approach the work. Member Lawrence noted that he hopes student interests will continue to be at the forefront of the administration's focus.

Mr. Lawrence noted that the Student Advisory Council has been continuing to prepare for its second Community Building Day event and its legislative action initiative. The purpose of the event this year is to bring to light the insecurity that many students are facing regarding basic needs. He added that the legislative action initiative is an effort to mobilize students to advocate for pro-student interests in bills to state and local officials. Community Building Week will take place from April 3 to April 7, 2023.

# **VI. ADVISORY COUNCIL REPORTS**

# A. Academic Affairs & Student Success

Academic Affairs and Student Success Advisory Council Co-Chair Patty Eppinger reported that Academic Affairs and Student Success met on March 14, 2023, and covered two different areas. One was the Massachusetts Inclusive Concurrent Enrollment Initiative (MAICEI). The other was an update on goal setting for the strategic plan for racial equity. MAICEI is intended to ensure inclusivity for students with intellectual disabilities, developmental disabilities, and autism. Co-Chair Eppinger noted that her council is working on a new higher education bill that will advance inclusive post-secondary education by removing barriers to it and by ensuring that guidelines for admission or selection are established.

Patty Eppinger noted that the goals of the Strategic Plan for Racial Equity are timely completion of gateway courses, on-time credit accumulation, persistence, transfer rates, degree completion after transfer, and degree or certificate completion. She added that Academic Affairs and Student Success had touched on workforce development initiatives, which will be the focus of the next meeting of Academic Affairs and Student Success.
