## **2023 Presidential Search Process**

#### October 2022

HCC signed a contract with Pauly Group, Inc. to conduct the Presidential Search. This is the same firm used when Dr. Royal was hired.

Presidential Search Committee selected. It was a 21-member group representing all stakeholders of HCC. A list of the Presidential Search Committee and their affiliation with HCC follows.

### November 2022

Pauly Group met with constituency groups of HCC in order to write the Position Profile and determine the specific needs of HCC.

#### December 2022

Orientation Meeting held between Presidential Search Committee and Pauly Group. Reviewed Position Profile, process moving forward, Open Meeting Laws, and Affirmative Action laws and policies.

Position Profile reviewed and edited by various stakeholders and approved by the Presidential Search Committee and Board of Trustees.

Position Profile made public on HCC and Pauly Group Websites.

## January 2023

The Presidential Search Website was developed and established on the HCC website.

Advertisements posted in National online publications.

Pauly Group actively recruited applicants for the position.

Search Committee Members individually screened and evaluated applications.

## February 2023

Search Committee Members individually screened and evaluated applications.

Application Close Date: February 21, 2023

50 Applications received in total.

#### **March 2023**

Search Committee met to identify nine semi-final candidates for first-round interviews.

March 22<sup>nd</sup>, 23<sup>rd</sup> & 24<sup>th</sup>: Search Committee interviewed semi-finalists for one hour each, followed by 30-45 minutes of discussion of each candidate, via Zoom.

The Search Committee identified four final candidates directly following the virtual interviews.

# **April 2023**

April 6<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup> & 13<sup>th</sup>: Finalists on campus for interviews and trustee interviews.

Each finalist experienced forums with all stakeholders, an interview with the Board of Trustees, dinner with two Board Members, and a ½

day (following the full day of interviews) for tours of the college and community.

Pauly Group conducted in-depth referencing on each finalist as well as criminal and civil background checks. Full reports submitted to the Board of Trustees prior to their decision.

Pauly Group surveyed anyone who participated in the open forums and developed a report of input regarding strengths and concerns about each finalist. The reports were given to the Board of Trustees prior to their decision.

April 25<sup>th</sup>: The Board of Trustees after significant deliberation and input from the audience, unanimously selected Dr. George Timmons as the next President of Holyoke Community College.
