#### **I. CALL TO ORDER**

Chairman Desmond called the meeting to order at 10:33 a.m. and invited Middlesex Community College President Carole Cowan to address the board.

#### **II. WELCOME**

President Cowan welcomed the Board of Higher Education to the campus and gave a brief overview of the college's history and its successes relating to the Vision Project. She also presented Board members with a book recently published that commemorates the 40<sup>th</sup> anniversary of Middlesex Community College.

#### **III. ACCEPTANCE OF MINUTES**

Chair Desmond brought forth a motion to approve the minutes of the May 31, 2011, interview with Massachusetts Bay Community College presidential candidate Dr. John O'Donnell. The motion was seconded and the minutes were approved unanimously by all board members present. Chair Desmond then brought forth a motion to approve the minutes of the June 7, 2011, Board of Higher Education meeting. The motion was seconded and the minutes were approved unanimously by all board members present.

**IV. CHAIRMAN'S REMARKS**

Chair Desmond introduced and welcomed this year's student board member Mr. Angel Donahue-Rodriguez of Salem State University. Chair Desmond then made remarks which included information on the \$5 million award from the U.S. Department of Education, the \$500,000 addition to STEM-education initiatives in the supplemental budget, the outreach that External Affairs is making to the broader community about the value of public education through the Go Public! events held on September 26, 2011, and September 27, 2011, and Bridgewater State University's ceremony to recognize BHE member Lou Ricciardi and announce the newly named "Louis M. Ricciardi College of Business".

**V. COMMISSIONER'S REMARKS**

Dr. Richard M. Freeland, Commissioner of the Department of Higher Education, thanked President Cowan for hosting the BHE meeting and made note of the 40<sup>th</sup> anniversary of Middlesex Community College celebrated last year. He welcomed the Department of Higher Education's new General Counsel, Dena Papanikaloau, and announced Dr. Shelley Tinkham's promotion to Assistant Commissioner.

Commissioner Freeland's comments to the Board also addressed recent and on-going building projects at public higher education institutions. He then discussed the Gates/Lumina/Hewlett Foundations' funding of Massachusetts as one of ten states recognized for their K-12 and higher education collaboration and noted that Massachusetts Community Colleges were awarded \$20 million through a U.S. Department of Labor grant.

Commissioner Freeland also discussed the PARCC Initiative, the Davis Education Foundation's funding of learning outcomes and assessment work, and the STEM Summit being held today. Commissioner Freeland also shared that the Vision Project report is currently in development and may be ready in September 2012. He also recapped the event held at Framingham State University where Governor Patrick congratulated the presidents of 18 campuses that received a share of the \$2.5 million performance incentive fund. He noted, as well, the presidential searches that are in progress at Cape Cod Community College and Berkshire Community College.

**VI. SECRETARY OF EDUCATION'S REMARKS**

Chair Desmond invited Secretary of Education Paul Reville to make remarks and thanked him for his leadership and commitment to making excellent public education accessible to low income and minority students. Secretary Reville offered brief remarks regarding the STEM conference; the challenging budget year that is ahead; Hispanic Heritage Month and Governor Patrick and the Legislature's honoring BHE members Angel Donahue-Rodriguez and Mario Borunda.

He also noted the application being filed for the Early Education and Care version of Race to the Top, Early Learning Challenge Grant and shared that UMass President Robert Caret has completed his bus tour and returned to UMass. Secretary Reville commented on the upcoming hearing on public higher education and career- and college-readiness and expressed thanks to President Cowan for her commitment to workforce preparedness. He congratulated the community colleges on receipt of the \$20 million Department of Labor grant and discussed the PARCC initiative and its role in transforming how we assess readiness and send signals to colleges

## **VII. REPORTS FROM PRESIDENTS**

- A. Dr. Patricia Meservey, President of Salem State University and Chair of the Executive Committee of State University Presidents, commented to the board by discussed doctoral program collaboration of UMass with state universities. She also commented on the growing enrollment numbers at state universities and the concern for the impact of corresponding economic strains.

President Meservey also noted the state universities partnering with the Massachusetts College of Pharmacy so that students can transfer to the Massachusetts College of Pharmacy to complete nursing programs. She also congratulated MassArt and UMass Lowell for competing in the U.S. Department of Energy Solar Decathlon.

- B. Dr. Wayne Burton, President of North Shore Community College, and Chair of the Community College Council of Presidents, made remarks to the board regarding the work being done in the areas of student disabilities and workforce development. He has made three trips to Washington DC in support of these efforts and noted the need for a higher education special education law. Campuses need resources in order to deliver special education students the programs they need. He also discussed workforce development for middle-skill jobs and addressed the need for accurate metrics to measure completion rates.

## **VIII. REPORT FROM STUDENT ADVISORY COUNCIL**

Mr. Angel Donahue-Rodriguez, this year's student board member and a student at Salem State University, shared with the board the efforts the Student Advisory Council has underway to elevate its profile through the DHE website, Twitter, and Facebook. He also noted that the Student Advisory Council's meeting dates will change to the third Thursday of each month with the exception of holidays.
