## **NOTICE OF COMMENT PERIOD**

Notice is hereby given pursuant to M.G.L. c. 69, § 30 and the Massachusetts Board of Higher Education's Policy Establishing a Process for Public Comment on Articles of Organization and Foreign Certificates of Institutions of Higher Education that the Massachusetts Department of Higher Education will open a comment period relative to the Articles of Amendment filed by the American University of Greece to offer the Master of Arts in Learning Design and Technology.

Higher Education (NECHE) and was the first European higher education institution to be accredited by a

US regional accreditor. In its current petition, AUG is seeking authority to offer the Master of Arts in

Learning Design and Technology retroactive to January 1, 2023.

The public comment period for the Articles of Amendment filed by the American University of Greece

begins on March 6, 2024 and will close three weeks thereafter, on March 27, 2024.
