## **NOTICE OF COMMENT PERIOD**

Notice is hereby given pursuant to [M.G.L. c. 69, § 30](#) and the [Massachusetts Board of Higher Education's Policy Establishing a Process for Public Comment on Articles of Organization and Foreign Certificates of Institutions of Higher Education that the Massachusetts Department of Higher Education](#) will open a comment period relative to **the Articles of Amendment filed by the Boston Graduate School of Psychoanalysis to offer the Master of Arts in Psychoanalytic Studies.**

The Boston Graduate School of Psychoanalysis is an approved independent institution in the Commonwealth of Massachusetts with the authority to grant the degrees of the Certificate in Psychoanalysis; the Certificate of Advanced Graduate Study in Psychoanalytic Psychotherapy; the Certificate of Advanced Graduate Study in Child and Adolescent Intervention; the Master of Arts in Psychoanalysis; the Master of Arts in Clinical Mental Health Counseling; the Master of Arts in Psychoanalysis, Society and Culture; the Doctor of Psychoanalysis; the Doctor of Psychoanalysis in Psychoanalysis, Society and Culture; and the Honorary Doctor of Humane Letters. Boston Graduate School of Psychoanalysis is now seeking the authority to offer the Master of Arts in Psychoanalytic Studies. The public comment period for the Articles of Amendment filed by the Boston Graduate School of Psychoanalysis to offer the Master of Arts in Psychoanalytic Studies begins on April 24, 2023, and will close three weeks thereafter, on May 15, 2023.
