Notice is hereby given pursuant to [M.G.L. c. 69, § 30](#) and the [Massachusetts Board of Higher Education's Policy Establishing a Process for Public Comment on Articles of Organization and Foreign Certificates of Institutions of Higher Education that the Massachusetts Department of Higher Education](#) will open a comment period relative to **the Articles of Amendment filed by Berklee College of Music to offer the Master of Arts in Music Supervision.**
