NOTICE OF COMMENT PERIOD

Notice is hereby given pursuant to [M.G.L. c. 69, § 30](#) and the [Massachusetts Board of Higher Education's Policy Establishing a Process for Public Comment on Articles of Organization and Foreign Certificates of Institutions of Higher Education that the Massachusetts Department of Higher Education](#) will open a comment period relative to **the Articles of Amendment filed by Lasell University to offer the Master of Education in Integrative Learning and the Master of Education in Montessori Integrative Learning.**

Lasell University is a private co-educational institution located in Newton, Massachusetts. Lasell University was founded in 1851 by Edward Lasell, a graduate of Williams College, as the Auburndale Female Seminary. Edward Lasell died of typhoid fever in the school's very first semester, and it was renamed Lasell Female Seminary in his honor. Adoption of the name Lasell Junior College came in 1932, and the College began issuing associate degrees instead of diplomas in 1943. In January 1998, the College amended its charter to include in its mission the education of both men and women. The institution received approval for its first graduate degree in 2002 and changed its name to Lasell University in 2019.

The University currently offers a variety of undergraduate degrees, and the following graduate degrees: Master of Business Management, Master of Education in Elementary Education, Moderate Disabilities, Curriculum, Leadership and Inclusion, Master of Fine Arts in Creative Writing, and Master of Science degrees in the following disciplines: Applied Sports Science Analytics, Athletic Training, Communications, Criminal Justice, Human Resources, Integrated Marketing Communication, Management, Marketing, Medical Sciences, Nutrition for Human Performance, Organizational Leadership, Project Management, Rehabilitation Science, Sport Management. In its current petition, the University is seeking to award the Master of Education in Integrative Learning and the Master of Education in Montessori Integrative Learning.

The public comment period for the Articles of Amendment filed by Lasell University to offer the Master of Education in Integrative Learning and the Master of Education in Montessori Integrative Learning begins on July 10, 2025, and will close three weeks thereafter, on July 31, 2025.
